EXHIBIT 1

Responses to Items 6 and 7(f)

At each annual meeting of the National Cable Satellite Corporation (“NCSC”), a non-profit corporation, the Chairman of the Board of Directors nominates and the Board of Directors approves, by majority vote, the Executive Committee. For reasons that are discussed below, the Executive Committee of the NCSC Board of Directors is the controlling entity of the board. Information in response to Items 6 and 7(f) of FCC Form 323-E, therefore, is provided only for the officers of NCSC and the Directors who comprise the Executive Committee.

Under Article V of the bylaws of NCSC, the Executive Committee of the Board of Directors has full authority to “exercise the authority of the Board of Directors in the management of the corporation,” except when the full Board holds its annual meeting and with respect to certain matters, which require action by the full Board. However, these exceptions to the Executive Committee’s authority have been included in the bylaws only to comply with District of Columbia and Federal rules and regulations pertaining to non-profit corporations. They do not, by themselves, indicate the locus of control of NCSC.

The excluded matters include: amending, altering, or repealing the bylaws; electing, appointing, or removing any Director or elected officer of NCSC; amending the articles of incorporation; restating the articles of incorporation; adopting a plan of merger or adopting a plan of consolidation with another corporation; authorizing the sale, lease, exchange or mortgage of all or substantially all of the property and assets of NCSC; authorizing the voluntary dissolution of NCSC or revoking proceedings therefore; adopting a plan for the resolution of the full Board of Directors, which by its terms provides that it shall not be amended, altered or repealed by such committee.

The broadcast interests of the members of the Executive Committee of NCSC, who are officers of the communications companies shown in response to Item 7, are a matter of public record with the FCC.
