METHODOLOGY:

Pierreport Consulting LLC in association with Mercury Analytics conducted online interviews from March 3-6, 2022 among n=1,011 U.S. likely voters.

The margin of error for this study is +/- 3.10% at the 95% confidence level and higher for subgroups. Some percentages may add to more or less than 100% due to rounding. Where applicable, tracked finings reflect prior C-SPAN Supreme Court studies.
